CONFERENCE

COMPLAINT ABOUT ANIMALS

A hearing scheduled on complaints received against Walden B. Kittredge, the nature of which were that he was keeping animals which created a nuisance at 320 Hollis Street was not held as Mr. Kittredge called the Board and stated that he did not have any animals there at the present time and that the Board of Health had inspected the premises and approved the same. He was advised not to keep any animals there in the future which would create a nuisance and the Board of Health would be instructed to make an investigation of the premises at monthly intervals.


- Morton Langthorne, 560 Waverly St., new store front, and addition (barricade) - Sept. 9 to ~~Oct.~~ 10.
