HEARINGS

A public hearing was held at 2 P.M., in the Selectmen's Office, Room 21, Memorial Building, on the petition of the Boston Edison Co. for one pole, guy wire and anchor on Higgins Road, approximately 115' north of Leigh St., was granted as no one was present favoring or opposing the granting of this petition.

A public hearing was held at 2:05 P.M., in the Selectmen's Office, Room 21, Memorial Building, on the petition of the New Eng. Tel. & Tel. Co. for permission to lay and maintain underground conduits and manholes, with the wires and cables to be placed therein, under the surface of the following public way or ways:

Bishop St., 96½ feet of underground conduit between Waverly St. and pole 19/1; Waverly St., 3 feet of underground conduit from Bishop St. to present conduit; Waverly St., abandon 7 feet of underground conduit between pole 227/30X and present conduit. Mr. Flanagan, representing the Tel. Co., was present in favor of the granting of this petition and no one was present in opposition to it. It was voted to grant the same.

A hearing was given Andre R. Gagne at 3:40 P.M., to show cause, if any he may have, as to why his license for the sale of alcoholic beverages, as an innholder, should not be suspended and/or revoked, as a result of a violation which took place on his licensed premises, 60-64 Kendall St., to wit: two glasses of ale to Lester J. Brady, a person under twenty-one years of age. Mr. Gagne, Chief McCarthy and Police Officer Mahoney were present. Officer Mahoney stated that November 19, he, together with Sgt. Mehigan went to the Dugout, so-called, at 60-64 Kendall St., which Andre R. Gagne was the licensee, as the result of a call to the police station. At this place he observed Lester J. Brady, a person under twenty-one years of age, in a booth trying to conceal a glass of liquor. Brady was questioned as to his age. He said that no one had asked him what it was. The licensee and his bartender were present. Both Brady and McCauley were present and were arrested the following Monday morning and proceedings were started against them by order of the court. Mr. Gagne testified that he was behind the bar and a colored fellow brought three beers over to the booth. He asked Brady his age and Brady stated that he was twenty-one. He said that only three beers to his knowledge were served, and that he had fired the bartender who had served them. Chief McCarthy stated that Brady does not look to be 21 years of age and that the original arrest of McCauley and Brady was for drunkenness, and that the judge upon hearing the

evidence instituted proceedings upon which the court made this finding of guilty. The Board voted to notify the licensee to surrender his license at midnight on January 2, 1950 for the sale of all alcoholic beverages as an innholder at 60-64 Kendall St., and not to sell or serve any alcoholic beverages on Tuesday, Wednesday and Thursday, January 3, 4 and 5, 1950.

REQUEST FOR RETIREMENT

The request of Willis A. Dunham, patrolman in the Framingham Police Department, was considered by this Board. It was voted to retire him on pension effective December 31, 1949.


CONFERENCES

A conference was held with Mrs. Julia Resteghini regarding her application for an annuity in accordance with Section 89 of Chapter 32 of the General Laws. Dr. Romano of the Framingham Community Hospital was present and the Dr. testified that on December 8, 1946 Joseph Resteghini, a patrolman in the Framingham Police Department, came to his hospital in uniform having been on duty in Framingham Centre. The Dr. testified that Officer Resteghini had suffered a severe hemorrhage and that he told him to return the next day for X-Rays. X-Rays were taken by Dr. Freidman. The X-Ray showed a large area affected and arrangements were made for Officer Resteghini to go to the Waltham Sanatorium. Dr. Romano then testified that this officer collapsed on duty, and as a result of a hazard undergone while in the performance of his duties as a police officer, such hazard, or hazards, contributed to his condition, and also his resistance caused him to contract T.B. After hearing the testimony of Dr. Romano, the Board found that while Joseph Resteghini was a police officer of the Town of Framingham, he underwent a hazard while in the performance of his duty, and as a result of this hazard the same contributed to his death, and the Board grants the annuity to his widow, Julia Resteghini, effective January 1, 1950.

A conference was held with Raymond J. Callahan, representing the Park Commissioners, regarding the care of the commons. Mr. Callahan agreed to take over the care of the commons in 1950 and submit a budget for \$1850. for the same.
