CONFERENCES

Arthur J. Ambuter and other residents of Little Tree Lane area conferred with the Board at 8 P.M. regarding drainage problems, and they stated two - 14" pipes were unable to carry water accumulated in the brook after a heavy rain. They stated that they had been assured at the hearings for the acceptance of Knight Rd. and Little Tree Lane that adequate drainage would be provided.

Chief Engineer Mackey stated that two - 30" pipes would provide temporary relief and only diversion of the brook would provide permanent relief.

The Board agreed to confer with representatives of SUASCO regarding their intentions in this area.

Alden Seltzer, Esq., conferred with the Board at 8:25 P.M. regarding the settlement of the case of Mrs. Bolieau for injuries sustained as a result of alleged sidewalk defect. He stated Mrs. Bolieau had incurred \$25.00 doctor's bills, \$40.00 for care at home, and \$10.00 for an elastic stocking, and loss of six weeks of work @ \$22.00 per week (\$132.00). He thought the case was worth at least \$1,000.00.

The matter was taken under advisement pending a conference with the Town Counsel and report from the Engineering Department.

Chief of Police McCarthy conferred with the Board at 9 P.M. on various departmental matters.

He was instructed to investigate the possibility of leasing cars for the Police Department.

SUSPENSION OF POLICE OFFICER

The Board voted to suspend Henry E. Richards from his duties as a police officer for failure to report for duty.

RESIGNATION OF ASSESSOR


It was voted to accept the resignation of Julian P. Hastings, as an Assessor, to be effective January 11, 1960.
