HEARINGS ON PETITIONS

A public hearing was held at 8 P.M. in the Selectmen's Office, Room 21, Memorial Building, on the petition of the Boston Edison Co. JO New Eng. Tel. & Tel. Co. for one pole location on Cochituate Road, northerly side, approximately 155' west of Burr St., three poles on Cochituate Road, southerly side, westerly from a point approximately 175' west of Burr St. (four existing JO poles to be removed). There was no objection to the granting of this petition and the same was granted.

A public hearing was held at 8 P.M. in the Selectmen's Office, Room 21, Memorial Building, on the petition of the Boston Edison Co. JO New Eng. Tel. & Tel. Co. for one pole location on Concord St., northwesterly side, approximately 485' southwest of Thelma Road (one existing JO pole to be removed). There was no opposition to the granting of this petition, and the same was granted.

CONFERENCES

Richard T. Mackey, Chief Engineer, conferred with the Board at 7:45 P.M. on various departmental matters.

He explained that he had looked at the various station wagons proposed, and that only the GMC Suburban is suitable for his purposes. The other station wagons do not have sufficient room, nor do they have rear doors that open to the sides.

On motion of John T. Dias, it was voted to award the contract to R. H. Long Motor Sales Company to supply one 1960 GMC Suburban for the Engineering Department.

The Engineer also discussed the matter of street lighting on Union Ave. and Concord St. and was authorized to contact the Edison Co. to start the project without installation costs to the town.

Chief McCarthy conferred with the Board at 8:15 P.M. on various departmental matters. He informed the Board that he had requested the Board of Public Works to install a traffic sign at the intersection of Edish and Joseph Roads, Madine Road, and at the intersection of Jean Street and Brook Street.

He was instructed to try the rotary traffic in the downtown business area - one way - Kendall St., from Concord St. to Frederick St., and on Frederick St., from Kendall St. to Concord St., between 4:15 P.M. and 6 P.M.

The Town Counsel reported that the only part of the restrictions on Sanger St. prohibiting parking on the southerly side is by a by-law adopted October 22, 1940. He was instructed to look into the matter further, in particular reference to the park at the intersection of Sanger and Pearl Streets. He was also instructed to look into the matter of Hadley Road extension and/or footpath.

STATE PUBLIC WORKS


It was voted to request a meeting with State Public Works Commissioner Anthony DiNatale regarding traffic problems at Framingham Centre.
