RATIFICATIONS

Action taken informally in granting permits was ratified as follows:

Obstruct sidewalk - Chiumento Signs, 169 Concord St., taking sign down, repairing and erecting sign, January 2 to January 9 (not Friday, January 3, 1964).

Open, occupy & obstruct st.-Worcester Gas Light Co.:

666 Waverly St., relaying existing gas service pipe, January 6 to February 6.

574 Brook St., installing new gas service pipe, January 6 to February 6.

AUTHORIZE TOWN COUNSEL TO SETTLE CASE

It was unanimously voted to authorize the Town Counsel to settle the case of Bertha Grill for injuries sustained as a result of an alleged sidewalk defect in the amount of \$1,000.

HEARINGS

A public hearing was held at 8:25 P.M. in the Selectmen's Office, Room 21, Memorial Building, on the application of Anchor Motor Freight, N.Y. Corp. for an extension for a period of six months ending June 30, 1964 of an existing permit to use an office trailer at 35 Western Ave.

James Cussen, representing Anchor Motor Freight, N.Y. Corp., informed the Board that they would like to use this trailer until their office building is completed.

There was no objection and it was unanimously voted to authorize the Building Inspector to issue a permit for the use of an office trailer on Anchor Motor Freight property for a six months period ending June 30, 1964.

A public hearing was held at 8:35 P.M. in the Selectmen's Office, Room 21, Memorial Building, on the application of William A. Conte, Lessee, for a license to use the land at 752-760 Worcester Road, for the storage of the following, aboveground: 500 gallons of motor oil in approved containers, 100 gallons of anti-freeze in approved containers, 90 pounds of grease in six cartridges, 100 gallons of kerosene in approved container, 100 gallons of alcohol in approved container, and storage of the following, underground: 16,000 gallons of gasoline, in three tanks, 550 gallons of fuel oil in one tank, and 550 gallons of waste oil in one tank. Attorney John St. Andre presented return receipts indicating abutters had been notified.

Harry Hume, an abutor, objected to allowing a gas station at this location.

Fire Chief Clyde Van Duzer stated that this installation would meet all requirements of state and local regulations.

It was unanimously voted to grant the license.

A hearing was held at 8:45 P.M. on the complaint of the Police Chief, Arthur Martins, of sale or service of alcoholic beverages to a minor by the Dramatic Club of Framingham, Inc. on December 20, 1963.

Present were Chief Martins and Armando Nobilini, Manager of the Dramatic Club of Framingham, Inc.

Chief Martins informed the Board that he has a written statement from William Phillips who is twenty years old and is presently charged with unarmed robbery on the morning of December 21, 1963. This statement indicates that William Phillips was served alcoholic beverages at the Dramatic Club of Framingham, Inc. on the evening of December 20, 1963.

Two young men who were with Phillips informed the Board that they were both over twenty-one years of age and had been with Phillips at the Dramatic Club of Framingham, Inc. on several occasions and Phillips had been served alcoholic beverages on each occasion. They stated that they were not members of the club, nor were they guests of a member.

Armando Nobilini stated that he felt that Phillips must have forged papers. He stated that Phillips had presented an identification card on previous occasions which indicated that he was over twenty-one years of age. He said that the Dramatic Club has thirty-five members.

Following the hearing, it was unanimously voted to suspend the license of the Dramatic Club of Framingham, Inc. for a period of seven days (from midnight on Tuesday, January 7, 1964 to midnight on Tuesday, January 14, 1964), to reprimand them, and to warn them that they must obey the regulations pertaining to clubs and admit members and guests only.

A hearing was held at 9:05 P.M. on complaint of Police Chief Arthur Martins, of sale or service to a minor by the Framingham Post #929, Veterans of Foreign Wars, on the morning of December 21, 1963.

Present were Chief Martins, William D. Kerr, John Grady, Joseph Muto, and Ralph Brown of the Post #929, Veterans of Foreign Wars.

Chief Martins informed the Board that the statement given by Phillips indicated that he went to the Veterans of Foreign Wars between the hours of midnight and 1 a.m. on December 21, 1963 and was served two bottles of Knickerbocker beer.

The two young men who had been with Phillips stated that they did go to the Veterans of Foreign Wars Post #929, but did not see Phillips consume the alcoholic beverages. They stated that they had been in the Veterans of Foreign Wars Post #929 on previous occasions and had seen Phillips purchase and consume alcoholic beverages.

William D. Kerr stated that a police officer was on duty at the Veterans of Foreign Wars Post #929 at the time of this incident. Phillips, Chris Quirk and others came into the bar and spoke with Kerr and with the police officer. Quirk purchased 4 bottles of beer and went into another room. Kerr did not see who consumed the beer. He stated that the Post has presently sixty-two paid up members and William Phillips is not a member nor does he have a guest card.

The matter was taken under advisement.

The petition of the Boston Edison Co. JO New Eng. Tel. & Tel. Co. for one hip guy and anchor on Worcester Road, from a pole located on northerly side, approximately 895' east of Cochituate Rd., on which a public hearing was held December 2, 1963, was granted January 6, 1964.

APPLICATION FOR CERTIFICATE OF INCORPORATION

The application of Alden R. Grove, 126 Lockland Ave., Framingham, and others not residents of Framingham, for a certificate of incorporation under the name of "Olde Bay Ridge Association, Inc." was approved as far as the Framingham resident is concerned and the Secretary of State so notified.
