HEARINGS

A public hearing was held at 8 P.M., in the Selectmen's Office, Room 21, Memorial Building, on the petition of the New Eng. Tel. & Tel. Co. for the following permission: underground cable, manholes, and handholes on Frost and Brook Streets, from pole 348/9, approximately 920' southeast of Edgell Rd., extending along Frost St. to and extending along Brook St. to pole 21/27, Fenwick St., from Brook St., southeasterly to pole 82/1 approximately 53' of buried cable. No one was present objecting to the granting of this petition, and the same was granted.

A public hearing was held at 8 P.M. in the Selectmen's Office, Room 21, Memorial Building, on the petition of the Boston Edison Co. JO New Eng. Tel. & Tel. Co. for three poles, (these are existing poles, no new poles to be set) on Elda Rd., northwesterly side, opposite and southwesterly from Eleanor Road. No one was present objecting to the granting of this petition, and the same was granted.

A public hearing was held at 8:20 o'clock P.M., in the Selectmen's Office, Room 21, Memorial Building, on the application of the Dennison Manufacturing Co. for a license to use the land at 105-147 Clark St. for the storage of 20,000 additional gallons of toluol in two underground tanks, for private use.

Neil Fitch presented return receipts indicating abutters had been notified.

Chief VanDuzer stated that he had approved the application.

There were no objectors, and the license was granted.

BUILDING INSPECTOR


