A public hearing was held at 8 P.M. in the Selectmen's Office, Room 21, Memorial Building, on the application of the New England Tel. & Tel. Co. for a license to use the land at 350 Cochituate Road for the storage of 20,000 gallons of #6 fuel oil in one underground tank, and 1,000 gallons of diesel fuel in one underground tank, for private use.

Edward P. Reidy and Charles Defendorf, representing the New England Tel. & Tel. Co., presented the return receipts indicating the abutters had been notified. There were no objections, and the license was granted.

A public hearing was held at 8 P.M. in the Selectmen's Office, Room 21, Memorial Building, on the petition of the Boston Edison Co. for one pole (one existing pole to be removed) on Raymond St., northwesterly side, approximately 285' northeast of Union Ave. No one was present objecting to the granting of this petition, and the same was granted.

A public hearing was held at 8 P.M. in the Selectmen's Office, Room 21, Memorial Building, on the petition of the New Eng. Tel. & Tel. Co. for the following permission: Concord Street and Elizabeth Circle, from manhole 226 on Concord St. to and extending along Elizabeth Circle to pole 626/1, approximately 13' of conduit. There was no objection to the granting of this petition and the same was granted.

\*CONFERENCE\*

A conference was held at 8:15 P.M. in the Selectmen's Office, Room 21, Memorial Building, regarding the sale of a portion of a parcel of tax title property on Lake Road.

Present were William Pickett and his Attorney, Edward Lembo, William Manion, representing the Land Acquisition Committee, Mr. & Mrs. Thomas Baker, Mr. Monahan, Mrs. Riegelhaupt, Mrs. Robert Wiener and several other neighbors.

The matter was discussed at considerable length. Following the conference, it was unanimously voted to reaffirm the sale of this parcel of land to William Pickett.

\*BONDS\*

It was unanimously voted that the sale of the \$340,000 2.70 per cent School Project Loan, Act of 1948 bonds (Nos. NEM 1 to NEM 68) dated September 15, 1964, payable September 15, \$70,000 in 1965 to 1967 and \$65,000 in 1968 and 1969 to Harris Trust and Savings Bank at the price of 100.0499 and accrued interest is hereby confirmed.

It was unanimously voted that the sale of the \$560,000 2.70 per cent School Project Loan, Act of 1948 bonds (Nos. SSI to SS112) dated September 15, 1964, payable September 15 \$115,000 in 1965 and 1966 and \$110,000 in 1967 to 1969 to Harris Trust & Savings Bank at the price of 100.0499 and accrued interest is hereby confirmed.

\*UNITED FUND FLAG\*


