PRESENTATION

Attorney John Garrahan and Attorney Jay Lander appeared to present a Mural of historic buildings in Framingham to the Town for installation in the Selectmen's hearing room. The mural was painted by Framingham Centre resident Mrs. John Crane. It was presented to the town on behalf of Attorney Carl Sheridan and Judge William Randall, who were the original partners of the firm represented by Mr. Garrahan and Mr. Lander. A plaque listing the public service record of these two gentlemen was also presented for installation with the mural.

CONFERENCE RE: SUDBURY LANDING CURB CUT

Mr. Dennis Paul, who had requested a meeting with the Board of Selectmen, notified the Selectmen just before the meeting that his attorney had not had the opportunity to prepare the information he felt was necessary and he requested that the hearing be postponed.

SAFETY OFFICER RECOMMENDATIONS

1. The Board reviewed a recommendation from the Safety Officer concerning the possibility of changing Stevens Road to one way. They voted unanimously that the Safety Officer should have agreement from the residents before any such move be made.
2. The Board voted unanimously to approve a Resident Parking sign in front of 56 South Street with the understanding that the petitioning resident would pay the cost.

Upon recommendation of the Executive Administrator, the Board voted unanimously to close the Memorial Building for the Christmas Holiday at Noon on December 24th and reopen on Monday, December 29th at 8:30 A.M. It was further voted that there would be no Selectmen's meeting scheduled for December 29.
