A. HEARINGS:

The Board addressed a request on the part of the New England Telephone & Telegraph Company for a conduit location on Joseph Road. Selectman John King removed himself from the proceedings. The Board approved the request.

HEARING:

The Board held a public hearing on taxi cab fees. Speaking in favor of an increase in cab fees, were John Thompson, Joanne Thompson and John Mabardy. Some reasons given for increasing fees were increased gasoline taxes, insurance, repairs, rentals, permits, meter costs and excise taxes. The Board voted to take the matter under advisement. The Board discussed the matter and then approved the increase as outlined in the letter of December 20, 1988 from Tommy's Taxi, Inc. The new rates will become effective February 13, 1989.

B. REQUESTS:

The Board approved the request of the Framingham Municipal Credit Union to have the new parking garage remain open on February 19, 1989 for the use by members of the Credit Union who will be attending the annual meeting.

C. CONFERENCE:

The Board approved the lease of a parcel of property to the Framingham Animal Humane Society as recommended by Town Counsel. The board also authorized a sign.

D. CORRESPONDENCE:

The Board noted receipt of correspondence from the Greater Precinct 12 Neighborhood Association regarding Bowditch Field signs and the Fire Department overtime for the week of January 21, 1989.

The Board noted receipt of correspondence from the Town Engineer re: One Way Streets - Proctor Street be made One Way from Franklin St. to Pearl St. Pearl St. be made One Way from Proctor St. to Franklin St.
